GDF SUEZ Energy Resources NA Expands Presence in Ohio Retail Electricity Market

OHIO – April 24, 2013– GDF SUEZ Energy Resources NA, one of the country's largest competitive retail electricity providers to commercial, industrial and institutional customers, announced today it has entered two new Ohio competitive retail electricity markets. The move broadens the pricing options and product offerings available for large commercial and industrial customers in the AEP Ohio and Duke Energy service territories. GDF SUEZ Energy Resources began pricing transactions on April 22 for service that starts June 2013.

Sam Henry, President and CEO of GDF SUEZ Energy Resources, said the expansion in these markets drives competition and brings more value in terms of pricing and product options to consumers.

"We have a lot to offer large energy buyers in the AEP Ohio and Duke Energy territories," Henry explained. GDF SUEZ Energy Resources has served the Toledo Edison, Cleveland Electric Illuminating, Ohio Edison, and Dayton Power & Light territories since June 2011. To serve the central and southern Ohio markets, the retail electricity provider recently opened a sales office in Columbus and plans to hire additional sales people who will specifically focus on that region of the Buckeye State.

Parent company GDF SUEZ Energy North America also has in its portfolio a 609 MW natural gas-fired power plant in Luchey, OH.

David Braun, Regional Vice President of the Midwest for GDF SUEZ Energy Resources, said further expansion into the Ohio market will allow more consumers to benefit from the company's commitment to being an information leader to large commercial and industrial electricity users.

"We've developed a unique model that puts consumer education at the forefront of every transaction," Braun explained.
