GDF SUEZ ENERGY RESOURCES RENEWS AGREEMENT SUPPORTING GULF CHEMICAL & METALLURGICAL CORPORATION'S COMMITMENT TO ENVIRONMENTAL RESPONSIBILITY

HOUSTON – May 20, 2015 – GDF SUEZ Energy Resources announced today that it is continuing its support of Gulf Chemical & Metallurgical Corporation's (GCMC) commitment to environmental stewardship by renewing its energy agreement through early 2017. Under the agreement, GDF SUEZ Energy Resources provides Renewable Energy Certificates (RECs) and peak load curtailment services for the company's Freeport recycling facility. GCMC is the world's leading recycler of spent petroleum refinery catalysts.

The contract reflects GCMC's long-standing focus on sustainability. In addition to this energy agreement, GCMC engages in a range of other programs aimed at continuous improvement in resource conservation, waste minimization, and pollution prevention.

Under the renewed agreement, GCMC will offset 10 percent of its electricity consumption with Green-e® Certified RECs provided by GDF SUEZ Energy Resources. Each REC represents the environmental attributes of, or benefits associated with, a specific quantity of energy generated from a renewable source, such as solar or wind. GDF SUEZ Energy Resources will also continue to provide GCMC with ERCOT price and peak load alert services at no cost to support the company's strategy of curtailing usage during periods of high consumption to decrease demand on the grid.

GCMC Chief Executive Officer and President Eric Caridroit said, "GDF SUEZ Energy Resources understands what it takes to be a true business ally. They have demonstrated their dedication to going beyond pricing transparency and reliability to deliver a level of value and service that sets them apart from their competitors.

"GCMC's commitment to environmentally responsible operations is paramount and a core part of our business. As an Environmental Service Company, we look for sustainable solutions in all aspects of operations, including energy consumption. This agreement is one of the many ways we're 'walking the talk.'"

Sam Henry, President and CEO of GDF SUEZ Energy Resources, added, "Our in-house energy experts take great pride in helping commercial and industrial customers build energy management plans that effectively balance environmental priorities with budget requirements and organizational goals. We're honored to continue our support of GCMC and are pleased with the confidence they have shown in us by renewing our agreement."

Bruce Craig, President of Ascentergy Corporation and GCMC's consultant, agreed with Caridroit, saying, "GDF SUEZ Energy Resources has continued to perform as an excellent retail provider of electricity and associated energy products, and has proven to be a valuable resource to GCMC."

The RECs provided by GDF SUEZ Energy Resources will have a measurable impact on greenhouse gas emissions. According to a calculator from the Environmental Protection Agency, the RECs are the equivalent to the carbon sequestered by 124,544 tree seedlings grown for 10 years, removing about 4,857 metric tons of CO₂ from the atmosphere or displacing the estimated annual greenhouse gas emissions of 1,023 passenger vehicles.
